Standard cover - minimum levels (based on your age) for Death and Total and permanent disablement 1 July 2024

The minimum level of cover applicable to standard cover for Death and Total and Permanent Disability (TPD) for smartMonday PRIME and smartMonday PRIME TESF increases on 1 July each financial year in line with the Consumer Price Index (up to 5% p.a.).

The following table outlines the minimum levels of cover that apply from 1 July 2024 and replaces information currently shown on page 3 of the smartMonday PRIME and smartMonday PRIME TESF Insurance Guides dated 1 June 2024.
