2. Either party can terminate the relationship by giving notice, in addition to other specific termination rights.

4. You will ensure you are meeting your legal and regulatory obligations, including without limitation:
 - > providing the member all applicable offer and disclosure documents required under law or policy,
 - > providing all personal advice to members in writing and maintaining adequate records, any transactions completed via the online Adviser Portal has explicit member consent and a copy of that consent is retained by you,
 - > you act promptly on any instructions from a member who is your client,
 - > you have agreed to provide specified services to smartMonday members who are paying you a fee, and you are providing said services and documenting this,
 - > any fee paid from smartMonday to you meets the *sole purpose test*; and
 - > you have the member's consent to charge the fee.

Terms and conditions

1. 5. We will issue you a unique User Name and Password that will enable you to access the Adviser Portal.
6. You must keep your User Name and Password confidential. You may share your User Name and Password within your practice, but you must not share it with any third party. You are responsible for any activity using your User Name and Password.
7. You must notify us immediately if you believe the confidentiality of your User Name and/or Password has been compromised. You are fully responsible for the acts or omissions of any person who obtains access to the Adviser Portal using your User Name and Password regardless of whether the act or omission has been authorised by you or not.
8. We do not accept any liability for loss or delay in acting on instructions submitted on the Adviser Portal. You agree that you are solely responsible for the actions undertaken when you access the Adviser Portal including any transactions made and the use, storage and security of any information accessed, downloaded, printed or otherwise stored.
9. Neither Aon or the Trustee make assertion as to the accuracy, timeliness or suitability of the information contained on the Adviser Portal. Furthermore We make no warranty that use and access of the Adviser Portal will be uninterrupted or error free. All representations (whether express or implied) and all other implied conditions, warranties and terms as to the provision of the Adviser Portal are otherwise excluded to the extent permitted by law.
10. We may with or without notice, and at Our absolute discretion, withdraw or restrict your access to the Adviser Portal.

11. We are not liable for any claims by you arising out of your use of the Adviser Portal. You agree to indemnify Aon and the Trustee for any claims arising out of your use of the Adviser Portal otherwise than in accordance with this Agreement.
12. You will inform Us if you change licensees or cease practicing.
13. You will co-operate with Us in the event there is a dispute about the validity of fees being charged to a member and any remediation action required.
14. We may collect, use, manage, store and provide access to your personal information in accordance with Our Privacy Policy and the Privacy Act 1988 (Cth). Should your personal information be incorrect or out of date, you undertake to inform us immediately.
