## Changes to fees in your smartMonday account

The smartMonday team would like to keep you up to date with changes that are happening to your superannuation account.

smartMonday is able to apply a discount to the Asset Administration Fee in some cases. These discounts are linked to the value of the <<Employer name>>. Due to a decrease in the value of the plan, the discount has been reduced and there has been an increase to the Asset Administration Fee that applies to your superannuation account. **How to calculate your fee:** *If your balance was \$50,000 and your fee was 0.53% pa, your asset administration fee would be calculated as follows: \$50,000 x 0.0053 = \$265.*
