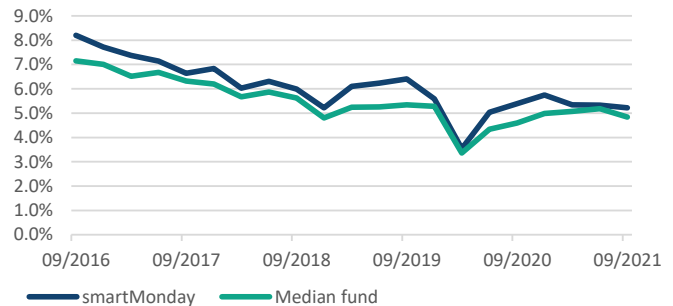

Shown compared to the SuperRatings Capital Stable (20-40) survey median fund return.

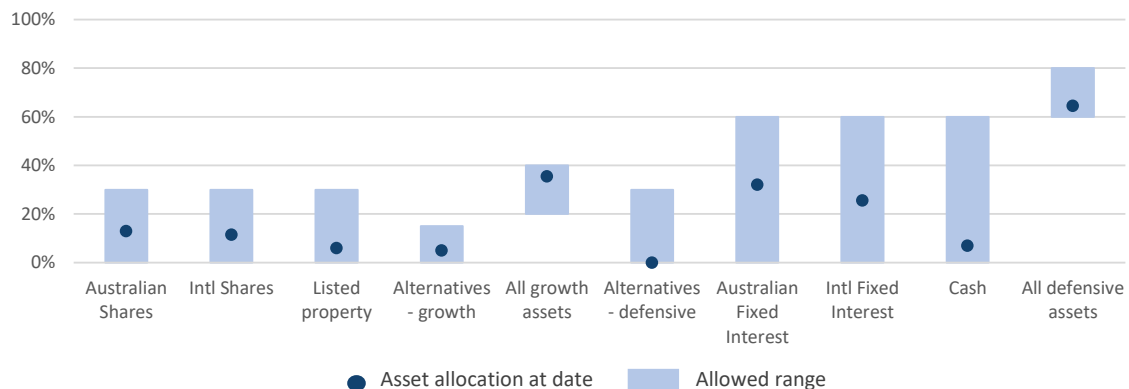
