



## smartMonday Super Growth - Active Option

### Objective

To provide a return at least 3.00% pa above inflation (after fees and taxes) over rolling 12-year periods.

### Strategy

Invests 80–90% of the portfolio in growth assets and typically 15% in defensive assets.

### Who is the Option for?

Intended to be suitable for those who can tolerate negative returns in some years because they intend to remain invested in this option for the suggested minimum timeframe.

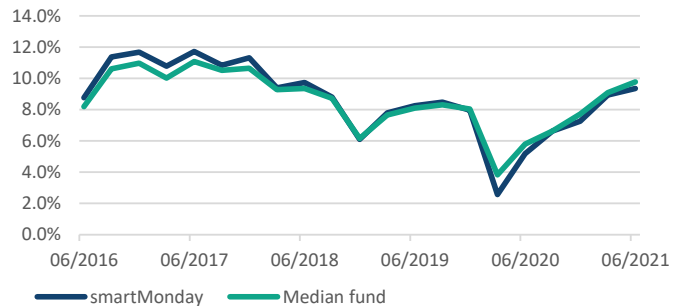

Shown compared to the SuperRatings Growth (77-90) survey median fund return.

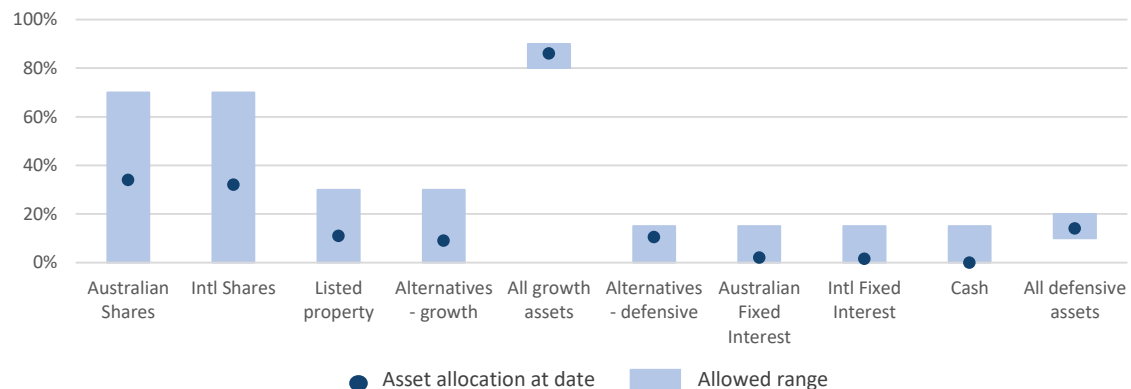
